Supervisor Eligibility Criteria for PhD Programs

In accordance with the Higher Education Commission's (HEC) Graduate Education Policy (GEP) 2023, the criteria for appointing PhD supervisors in Pakistan are as follows:

1. Qualifications and Experience:

- **Educational Background:** The supervisor must hold a PhD degree in a relevant field.
- **Research Activity:** Active engagement in independent research is required, demonstrated by recent publications in reputable journals.

2. Professional Conduct:

- **Availability:** Supervisors should have sufficient time to provide comprehensive guidance and constructive feedback to their PhD candidates.
- **Ethical Standards:** Maintaining professionalism, confidentiality, and protecting the intellectual property rights of the student's research is essential.

3. Institutional Affiliation:

- **Faculty Status:** Primarily, supervisors should be regular or adjunct faculty members of the university where the student is enrolled.

4. Trainings Requirements:

- Must have courses/trainings for supervision

5. Supervisory Load:

- **Student Limitations:** A supervisor may oversee a maximum of five PhD students simultaneously.
- **Experience-Based Allocation:**
 - **Fresh PhD Holders:** Individuals who have recently obtained their PhD can supervise MS/MPhil students and co-supervise PhD candidates.
 - **Post-PhD Experience:**
 - **After 2 Years:** Eligible to supervise one PhD student in their third year.
 - **After 3 Years:** Eligible to supervise two PhD students in their fourth year.
 - **After 5 Years:** Eligible to supervise up to five PhD students.

6. Publication Requirements:

In addition to fulfilling the General Requirements, a PhD supervisor must publish research articles in the HEC's recognized research journals and the category specified in the HJRS for the publication year. These conditions are different for different disciplines and aim to ensure that the potential PhD supervisor is an active researcher:

A. Specific Requirements for Science and Technology: For indigenous and foreign PhDs:

i. Within the last 3 years after PhD: at least one research publications in W category journal.

OR

ii. Within last 5 years after PhD: at least five research publications in X category journal.

B. Specific Requirements for Social Science, Arts and Humanities and Business Education: For indigenous and foreign PhDs:

i. Within the last 3 years after PhD: at least one research publication in W category journal.

OR

ii. Within the last 5 years after PhD: at least five research publications in X and Y category journal.
